$\Rightarrow$ For General Assembly Candidates, an original of this form must be submitted to the State Board of Elections at 1100 Bank Street, Richmond, VA 23219 and a copy must be submitted with the local electoral board of the county or city in which the candidate is a resident.
$\Rightarrow$ All requested information on the form is required unless otherwise noted below.
$\Rightarrow$ An amended Statement is required to be filed within 10 days of the change if any of the information reported on this form changes. Failure to amend this form in a timely fashion may result in civil penalties of up to $\mathbf{\$ 5 0 0}$ to be assessed according to the procedure described in §24.2-929 of the Code of Virginia.
